

Terms & Conditions - Canyon Road Rides

1. Traffic Safety and Procedure of the Tours

In the interest of the safety of all participants, the instructions of the tour guide must be followed at all times. Participants are not allowed to leave the group without the agreement of the tour leader.

2. Liability

Cycling is an independent activity. Participation in all tours is therefore at your own risk.

Canyon Bicycles GmbH as organizer or the individual employees of Canyon Bicycles GmbH shall only be liable for any damage resulting from injury to life, body or health if such damage was caused by intent or negligence, but not if it was caused by other participants or third parties. Canyon Bicycles GmbH as organizer or the individual employees of Canyon Bicycles GmbH shall only be liable for other damages if these were caused by intent or negligence.

All liability obligations on the part of the organizer and tour leader shall lapse if the road traffic regulations are disregarded or the instructions of the tour leader are not followed. No liability is assumed for personal equipment or for hazards caused by oneself or third parties.

3. Data Protection Declaration

By entering my data and pressing the "Register now" button, I agree that the data I have entered may be used for the registration and administrative execution of the Canyon Road Rides. By activating the checkbox "Newsletter" I agree that my data may be used for a regular newsletter dispatch. Terms & Conditions - Test Bike

1. Exclusion of Liability

Canyon Bicycles GmbH excludes any liability for damages caused directly or indirectly by the use of this bike! The bicycle is NOT insured.

The use of this bike is at your own risk. The renter confirms with the hook in the checkbox that he is covered by health insurance in the event of an accident or that he will pay for the costs of medical treatment himself. Canyon is not liable for damage caused by the use of the bike. Liability for participation in guided tours through Canyon is also excluded.

2. Passing-on of the Bicycle

The passing on of this bicycle to third parties is strictly prohibited.

3. Damage/Damage Report

Damages must be reported immediately. Also accident damage to third parties, protocols and reports, as well as total loss through accident, embezzlement or theft.

There is no usage fee.

4. Handover/Return

Before taking over the wheel the tester has to convince himself of the condition of the wheel. Any complaints are to be reported to the user. After the agreed time the bike has to be returned immediately.

5. Miscellaneous

Wearing a helmet is obligatory during appropriate trips. The traffic rules must be observed. The renter receives a clean and technically perfect bicycle for temporary use. The bicycle must only be parked in a locked and safe place. Theft insurance is not included. Avoid leaning against the frame, caliper, brake disc or rear derailleur, preferably on the raised pedal or rear wheel.
